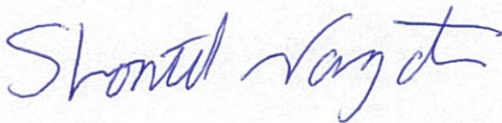
### RESULTS OF ANNUAL GENERAL MEETING - REISSUED
