PLACEMENT, APPENDIX 3B AND SECONDARY TRADING NOTICE

Platypus Minerals Ltd (“Platypus” or “Company”) advises the market it has placed 116,000,000 ordinary shares, at an issue price of 0.1 cents each, to sophisticated and professional investors, raising \$108,344 after costs, being a 6% placement fee. The placement was made pursuant to the Company’s “15%” capacity under Listing Rule 7.1.

An Appendix 3B relating to the issue is attached.

The funds will be applied towards administrative and operational requirements related to the Company’s activities in Peru, including the advancement of the proposed acquisition of Matriz Resources Limited, as announced to the market on 5 February 2014. Matriz holds access rights to certain strategic properties in the Chanape region of the San Mateo Mining District prospective for copper-gold mineralisation. In combination with the Company’s current holdings, the Matriz ground would give the Company a controlling ground position in what is becoming a very exciting area.
